EXHIBITION SPACE AGREEMENT

Rhythm Hound (Lessor) hereby leases to Exhibitor exhibit space for the Spring Music & Media Show as identified in the Application submitted by the Exhibitor subject to the terms of that Application, the following terms and conditions, all information sheets issued within a reasonable time before the show, and all city, state, and federal laws which, although they may not be referred to herein, are specifically made part of this agreement.

Exhibitor agrees to pay Lessor the amount set out in the application for the use of this exhibit space. It is understood that the exhibit space provided to the Exhibitor shall be one of many exhibit spaces comprising a given exhibition.

TERMS AND CONDITIONS

01. Lessor shall organize, promote and lease the exhibit space for the exhibition described on the Show Application. An information sheet will accompany this contract. The information sheet will contain information on the merchandise allowed to be sold or displayed, exhibition times and setup requirements.
02. Lessor shall provide media advertising for this exhibition.
03. Lessor reserves the right to assign all space locations and make space assignment changes prior to the exhibition opening as may be necessary to be consistent with good exhibition management procedures.
04. Lessor is not responsible or liable for the loss or damage to Exhibitor's property from theft, mysterious disappearance, damage by fire, water, accident or any other cause.
05. Lessor makes no representations or warranties not expressly set forth herein.
06. Exhibitor agrees to operate the tables or exhibit in accordance with the best interests of the exhibition, good taste, and the standards established by the Lessor. Lessor shall have sole discretion to determine whether Exhibitor's exhibit and or products are in compliance with this agreement.
07. Exhibitor agrees to keep exhibit within the boundaries of the space leased and arrange the exhibit in such a way to avoid interference with other exhibits.
08. Exhibitor agrees to have exhibit set up, complete and clean prior to the opening of the exhibition and to keep his/her exhibit open during all hours the show is open to the public.
09. Exhibitor agrees to be responsible for the payment of damage charges assessed by the Exhibit Hall for failure to observe the rules and regulations for the construction and operations of his/her exhibit.
10. Exhibitor accepts total responsibility for his/her exhibit and its safety and agrees to conduct his/her activities on the exhibition premises so as not to endanger any person lawfully thereon.
11. Refunds will not be made unless the exhibition is not held for reasons other than the malfeasance of the Lessor, e.g., due to disaster, flood, fire, etc.
12. Exhibitor agrees to indemnify, defend and protect Lessor against and hold and save Lessor harmless from any and all claims, demands, suits, liability, damages, loss or costs of whatever kind or nature which might result from any of the Exhibitor's merchandise or from any action or failure to act by Lessor or any of his/her family, officers, agents, employees, or other representatives, including but not limited to claims of damage, loss harm or injury to the person or property of Exhibitor or any of his/her family, officers, agents, employees, or other representatives, or of third persons.
13. Exhibit space will be reserved and booth numbers assigned when Show Application is accepted by Lessor and payment is made in full.
14. Exhibitor agrees that his/her submitted Show Application, the Information Sheet, and the Confirmation Sheet issued to confirm reservations in the exhibition referenced on the Show Application along with the terms and conditions herein are made part of this Agreement, and that he/she has read same.
